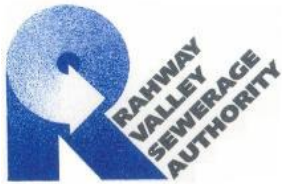
Re: Flow Rights Utilization Report - September 2017

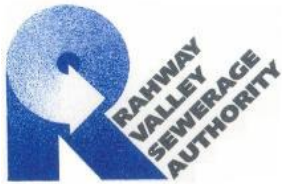

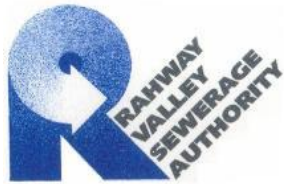

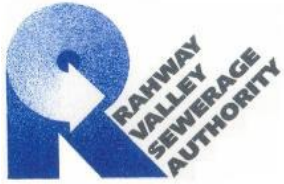
