## RAHWAY VALLEY SEWERAGE AUTHORITY 2025 ANNUAL MEETING NOTICE

The Rahway Valley Sewerage Authority's Meeting Schedule for the period February 20, 2025, through February 19, 2026, is as follows:

REGULAR MEETINGS are scheduled on the third Thursday of each month, with the exception of the April, June, and November Meetings\*, which will take place on the second Thursday of the month.

MEETING DATES: February 20, 2025, March 20, 2025, \*April 10, 2025, May 15, 2025, \*June 12, 2025, July 17, 2025, August 21, 2025, September 18, 2025, October 16, 2025, \*November 13, 2025, December 18, 2025, January 15, 2026, and February 19, 2026.

The annual CONNECTION FEE PUBLIC HEARING is scheduled to take place on November 13, 2025 at 6:30 p.m. In accordance with N.J.S.A. 40:14A-8(b), a public hearing will be held to discuss the annual adjustment to the Authority's Connection Fee for sewer connections, to take effect January 1, 2026. The purpose of the hearing is to present evidence that the proposed adjustment is necessary and reasonable, and provide an opportunity for cross-examination of persons offering such evidence. Interested members of the public are welcome to attend, comment, and ask questions. A transcript of the hearing will be available for public inspection during regular business hours at the Authority's Administrative Office within fourteen (14) days of the hearing.

All meetings are scheduled to begin at 5:30 p.m. with the exception of the Annual Connection Fee Public Hearing. All meetings will be held in the Boardroom of the Rahway Valley Sewerage Authority Administration Building, 1050 East Hazelwood Avenue, Rahway, NJ, 07065.

Meetings may also be held electronically via Zoom Video Conference when it is determined necessary. In the event of a remote meeting, participation will be allowed when the Chairman opens the meeting to the public.
